She handled significant components of the corporate restructuring and regulatory approvals in advance of the sale of CIGNA's property/casualty business, positioning CIGNA to focus on its health care business. As a member of departmental leadership teams, Ms. Ward developed and implemented strategies for and beyond these functions, creating policies and practices to guide and promote inclusive cultures across borders. She identified and implemented various initiatives to improve services while reducing costs. She also devoted considerable energy to talent development, serving as sponsor and mentor to many talents within and outside her own organizations.
